Installation of all materials is considered acceptance and no claims will be honored after installation. No refunds or cancellations on Special orders. Freight Charges must be added to the cost of Special orders. No returns on installation materials"*

No merchandise will be returned unless authorized by American Import Tiles, Ltd. All merchandise purchased from American Import Tiles, Ltd. will remain their property until full payment has been received. We agree that if the merchandise ordered by us or any other designated person shall remain past the invoice due date, any balance so remaining unpaid shall bear interest at the lesser rate of 1.5% per month which is an ANNUAL RATE OF 18%, or the maximum rate applicable by law, until paid. In the event of any suit or action, we both agree to pay, in addition to the amount owed, all collection fees incurred, including a reasonable sum for attorney's fees plus a 20% surcharge on all unpaid principle plus interest accrued. This is a continuing guarantee and the obligations created hereby are unaffected by any change in the terms of the original indebtedness between American Import Tiles, Ltd. and the applicant.

## Personal Guarantee

In consideration for the extension of credit by American Import Tiles, Ltd. This guarantee shall remain in full force and effect and the undersigned shall not be released from their obligations hereunder so long as any claim of AIT against Customer which arises out of, or relates to, directly or indirectly, terms expressed on the invoice, is not settled to the satisfaction of AIT or discharged in full.

The undersigned hereby expressly waives (a) notice of acceptance of this guarantee by AIT, (b) notice of any default or non-performance of Customer under the terms expressed on the invoice, (c) notice of any modification to the terms expressed on the invoice or any extension of time granted to the Customer, and (d) all defenses, offsets and counterclaims which the undersigned may at any time have to any claim of AIT against Customer. The undersigned expressly acknowledges that amendment or modification of the terms expressed on the invoice or the renewal or extension of any indebtedness of Customer shall not in any manner release, affect or impair their liability under this guarantee.

AIT may, in its discretion, proceed against the undersigned, jointly and severally in the case of multiple guarantors, to collect any obligation covered by the guarantee without first proceeding against Customer. Upon five days written notice by AIT, the undersigned shall pay any and all indebtedness, damages, costs and expenses due AIT by Customer and shall perform any and all duties of Customer to AIT.

This guarantee shall be construed pursuant to the laws of the State of Illinois, shall insure to the benefit of AIT, its successors and assigns, and shall be binding on the undersigned, their heirs and assigns.

Any notice to be given to the undersigned may be sent to the address provided below, and all communications so sent, whether by mail, fax, E-mail, messenger or otherwise, shall be deemed duly given to the undersigned personally, where or not actually received. Notices sent by mail shall be deemed duly given on the business day immediately following the date of the mailing.



All disputes, claims or actions or proceedings arising directly or indirectly from or in connection with this guarantee shall be litigated at the election of AIT only in the courts whose sites are within Cook County, Illinois, and the undersigned hereby submits to the jurisdiction of any state or federal court located within Cook County, State of Illinois, appoints and designates AIT (or any other party whom AIT may from time to time hereinafter designate) as the undersigned's true and lawful attorney-in-fact and duly authorized agent for service of legal process, and agrees that service of such process upon AIT or such other party shall constitute personal service of such process upon the undersigned; provided that AIT or such other party shall, within 10 business days after receipt of any such process, forward the same by registered or certified mail to the address provided below. The undersigned waives any right, which they may have to transfer, or change the venue of any litigation brought against the undersigned by AIT.

All pronouns shall be deemed to refer to the masculine or feminine, as the identity of the person may require, and the singular shall import the plural in the context of this guarantee.
